

## Japan Airport Terminal Group Environmental Policy

### (Purport)

In view of its mission as a corporate group responsible for the construction, management, and operation of passenger terminals that are of highly public nature, we the Japan Airport Terminal Group will pursue, according to our Sustainability Basic Policy, the establishment of a sustainable airport that is in harmony with the global environment, in cooperation with our stakeholders. Under the Policy, we will build a promotion system to reduce environmental impact, work to protect the environment, and strive to prevent events that may harm the environment. By implementing these initiatives in a secure and steady manner, we will contribute to the achievement of a sustainable society through our business activities.

### (Scope of Application)

This Policy applies to all officers and employees of the Japan Airport Terminal Group. Regarding business partners, etc., we will apply the "Japan Airport Terminal Group Sustainable Procurement Guidelines" in accordance with this policy.

### (Compliance with Laws and Regulations)

The Japan Airport Terminal Group will comply with environmental laws and ordinances, international declarations and conventions, industry and in-house standards.

### (Environmental Conservation Efforts)

The Japan Airport Terminal Group will promote the below-mentioned initiatives throughout its business activities.

#### (1) Measures against climate change

- (a) We will reduce greenhouse gas emissions from airport facilities and business vehicles.
- (b) We will engage in the procurement of renewable and/or new energies in addition to practicing energy saving activities.

#### (2) Effective use of limited resources

- (a) Based on the concept of 3R (Reduce, Reuse, Recycle), we will reduce plastics and other waste.
- (b) We will use water resources effectively by saving water and reusing gray water including rainwater and wastewater.
- (c) We will work on the development and sales of upcycled products.

#### (3) Prevention of environmental pollution

- (a) We will properly dispose of waste and prevent environmental pollution.

(4) Consideration for biodiversity

- (a) We will consider the conservation of biodiversity through the trading of certified and biodiversity conservation-friendly products.
- (b) We will trade a wider range of ethical products including eco-friendly products.

(Pursuit of Environmental Impact Reduction Measures and Continuous Improvement)

The Japan Airport Terminal Group will continue to pursue measures that lead to a reduction in environmental impact through cooperation with its business partners. The Group will also work to continuously improve these efforts and the overall environmental management system.

(Awareness-raising Activities)

The Japan Airport Terminal Group will provide all of its officers and employees with appropriate training to raise awareness about the environment.

(Information Disclosure)

The Japan Airport Terminal Group will strive to disclose its progress in its environmental conservation initiatives.
