

## Tokyo International Airport (HANEDA) Environmental Partnership Regulations

### (General provisions)

Article1 These regulations stipulate that Japan Airport Terminal Co., Ltd. (hereinafter referred to as the "Company"), in cooperation with the East Japan Civil Aviation Bureau of the Ministry of Land, Infrastructure, Transport and Tourism (hereinafter referred to as the "East Japan Civil Aviation Bureau") and all other stakeholders (hereinafter referred to as the "Airport stakeholders, etc."), will promote environmental initiatives such as decarbonization in line with global standards and promote the improvement of environmental activities.

### (Purpose)

Article 2 The purpose of these regulations is to promote the reduction of the environmental burden throughout the airport by setting out the necessary matters to be observed for the Company and Airport stakeholders, etc. to raise environmental awareness and actively promote efforts to reduce the environmental burden.

### (Environmental conservation efforts and indicators)

Article 3 When carrying out activities within the airport, the Company and Airport stakeholders, etc. shall take into consideration the spirit of the Airport Act (Act No. 80 of 1956), the Aviation Act (Act No. 231 of 1952), and other environmental related laws and regulations as well as these regulations, comply with the "Tokyo International Airport Decarbonization Promotion Plan"(hereinafter the "Promotion Plan") established by Tokyo International Airport Decarbonization Promotion Council (hereinafter referred to as the "Council") , and shall proactively address the following items.

- (1) Reducing greenhouse gas emissions
- (2) Promoting energy conservation

2. In setting targets for reducing environmental impact, the Company will assist in the promotion of such targets based on the numerical values in the Promotion Plan compiled by the East Japan Civil Aviation Bureau.

### (Data Management)

Article 4 The Company will receive data from the airport stakeholders solely for the purpose of external information disclosure and verification (obtaining Airport Carbon Accreditation from the Airports Council International (ACI)).

- 2.The data to be provided will include electricity, gas, heating, cooling, and water usage, waste emissions, and other basic data for Tokyo International Airport, which is managed by the East Japan Civil Aviation Bureau.

(Awareness-raising activities)

Article 5 Airport stakeholders, etc. shall share with their employees the significance of conducting environmentally friendly business activities and endeavor to raise employee awareness of efforts to reduce environmental burden.

(Cooperation system)

Article 6 When the Company deems it necessary to ensure the proper implementation of these Regulations, it may, in cooperation with the Council, request the cooperation of Airport stakeholders, etc.

2. Airport stakeholders, etc., endeavor to cooperate when they receive a request as set forth in the preceding paragraph.
3. In addition to the matters set out in these Regulations, the procedures and other matters necessary for the implementation of these Regulations will be determined in consultation with the Council.

(Supervising department)

Article 7 The Sustainability Management Office shall be responsible for the formulation and revision of these regulations.

(Supplementary provisions)

1. These regulations shall come into effect on November 20, 2025.
